**RSC-NCR Resolution 02**  
**Series of 2017**

**APPROVING THE SCHEDULE OF THE REGULAR MEETINGS OF THE  
REGIONAL STATISTICS COMMITTEE–NATIONAL CAPITAL REGION (RSC–NCR)**

**WHEREAS**, the region needs direction and guidance in its statistical activities in order to address regional/local issues as well as national government concerns;

**WHEREAS**, Republic Act No. 10625 (Philippine Statistical Act of 2013) created the Philippine Statistics Authority (PSA) and mandated the PSA to implement policies on statistical matters and coordination, as directed by the PSA Board;

**WHEREAS**, the PSA Board created the Regional Statistics Committee (RSC) thru Board Resolution No. 5 Series of 2015 to provide direction and guidance to regional/local statistical development activities;

**WHEREAS**, Article III of PSA Resolution no. 5 series of 2015 stipulates that the RSC shall meet at least once a quarter at such date, time and place it may decide to formulate policies on all matters relating to statistical operations, standards and classifications which are approved through a Resolution;

**WHEREAS**, the RSC-NCR shall hold regular meetings on the second Wednesday of the second month of each quarter, at a time and venue to be determined by the Secretariat;

**NOW, THEREFORE, IT IS HEREBY RESOLVED**, that the RSC-NCR approve the conduct of its regular meetings for the three-year term from 2017 to 2019 (Attachment 1)

**RESOLVED FURTHER** that:

- (1) Should the specified schedule be declared a holiday or be postponed due to force majeure or other fortuitous events, the meeting shall be held on the next available Wednesday or any day thereafter; and
- (2) Should agenda items require urgent discussion/resolution from the Board, special meetings/referenda may be conducted for the purpose.
