**ROBAC Resolution No. 02, Series of 2020**

**A RESOLUTION DECLARING FAILED BID ON LOT NO. 12 ON PUBLIC BIDDING NO. 2019-004  
AND RECOMMENDING NEGOTIATED PROCUREMENT THROUGH SHOPPING**

**WHEREAS**, ROBAC decided to repost the Invitation to Bid for the Procurement of 2020 CPH Office Supplies (Public Bidding No. 2019-004) on Lots 1, 2, 11 and 12. No supplier submitted proposals for the items during Bid Opening for the First Bidding conducted on December 16, 2019;

**WHEREAS**, ROBAC posted Invitation to Bid for the Procurement of 2020 CPH Office Supplies and Materials - Second Bidding at Philippine Government Electronic Procurement System (PhilGEPS) and at a conspicuous place within the building from December 19 to January 20, 2020;

**WHEREAS**, on January 6, 2020 ROBAC issued a Notice of Postponement on its Pre-Bid Conference to inform the prospective suppliers/bidders on its changes: from January 6 to January 23, 2019, 10:00 AM., same venue due to no quorum obtained;

**WHEREAS**, on January 15, 2020 ROBAC issued Supplemental Bid Bulletin No. 2 to amend the schedule of the procurement activity in the Bid Documents;

**WHEREAS**, the second bidding for Lots 1, 2, 11 and 12 was conducted on 05 February 2020 where Lot 12 (Printing Services for Identification Cards) remains to be a failure during the Submission and Opening of Bids;

**WHEREAS**, there were thirty (30) suppliers who viewed the second Bidding but only MB Pelaez School Office Supplies submitted proposal with samples on February 3, 2020;


**WHEREAS**, Section 35 of RA 9184 and its 2016 Revised IRR provides that "[t]he BAC shall declare the bidding a failure when: a) No bids are received.

**WHEREAS**, Section 35.5 of the 2016 Revised IRR of RA 9184 provides that should there occur a second failure of bidding, the Procuring Entity may resort to Negotiated Procurement, as provided for in Section 53.1 of the same IRR;


**WHEREAS**, the 2016 Revised IRR of RA 9184 does not provide a period for the conduct of re-bidding and Negotiated Procurement under Two Failed Biddings modality;

**NOW**, therefore and in consideration of the foregoing, we, the Members of the Regional Office Bids and Awards Committee, hereby **RESOLVED** as it is hereby **RESOLVED**, to declare the bidding for Lot 12 a failure and recommends to conduct a negotiated procurement through shopping for Lot No. 12 (Printing Services for 2020 CPH Identification Cards).




