**A RESOLUTION OF THE PSA-NCR REGIONAL OFFICE BIDS AND AWARDS COMMITTEE
RECOMMENDING TO DELEGATE TO THE END-USER THE CONDUCT OF NEGOTIATED
PROCUREMENT (EMERGENCY CASES) ON THE PROCUREMENT OF RENTAL OF
TRANSPORTATION SERVICES DURING ENHANCED COMMUNITY QUARANTINE**

WHEREAS, RA 10625 otherwise known as the Philippine Statistical Act of 2013 mandates the Philippine Statistics Authority (PSA) as primarily be responsible for all national censuses and surveys, sectoral statistics, consolidation of selected administrative recording system and compilation of national accounts;


WHEREAS, Resolution No. 22, series of 2020 of the Inter-Agency Task Force (IATF) for the Management of Emerging Infectious Diseases allowed the PSA to operate at a capacity necessary to conduct data gathering and survey activities related to COVID-19, including those related to the registration and implementation of the National Identification System during the implementation of Enhance Community Quarantine (ECQ);


WHEREAS, under GPPB Circular 01-2020 dated 6 April 2020 "Guidelines for Emergency Procurement under Republic Act No. 11469 or the Bayanihan to Heal as One Act", the HoPE is encouraged to delegate the authority to directly negotiate or conduct the procurement activities to the End-user unit or any other appropriate bureau, committee, support or procuring unit to expedite the procurement of highly needed supplies, materials, equipment, utilities, telecommunications, and other critical services;


WHEREAS, the ROBAC member unanimously agreed to authorize the end-user to undertake the procurement of Rental of Transportation Services for the conduct of data gathering and surveys during enhanced community quarantine;

NOW, therefore and in consideration of the foregoing, we, the Members of the Regional Office Bids and Awards Committee, hereby **RESOLVED,** to recommend to the Head of the Procuring Entity the approval to delegate to the end-user the conduct of negotiated procurement (emergency cases) of Rental of Transportation Services during the effectivity of enhanced community quarantine.


