ROBAC Resolution No. 10, Series of 2020

A RESOLUTION DECLARING FAILED BID ON THE NEGOTIATED PROCUREMENT OF A NINE (9) MONTHS LEASE CONTRACT OF AN OFFICE SPACE OF PSA NCR I FOR 2020 CPH DATA PROCESSING CENTER AND CENSUS HEADQUARTERS

WHEREAS, RA 10625 otherwise known as the Philippine Statistical Act of 2013 mandates the Philippine Statistics Authority (PSA) as primarily be responsible for all national censuses and surveys, sectoral statistics, consolidation of selected administrative recording system and compilation of national accounts;

WHEREAS, the Request for Quotation on the Procurement of Lease of an Office Space of PSA NCR I for 2020 CPH Data Processing Center and Census Headquarters with an Approved Budget for the Contract (ABC) in the amount of One Million Five Hundred Twelve Thousand Pesos (Ph 1,512,000.00) was posted at PhilGeps on March 6 to 16, 2020 and also at a conspicuous place within the building;

WHEREAS, on March 10, 2020, the End-user sent the Request for Quotation for the prospective bidders namely: J & T, PBS (Lush Properties Inc) and FORC Building;

WHEREAS, only Lush Properties Inc who submitted quotation before the closing date of the first posting on March 16, 2020;

WHEREAS, after careful review and evaluation on its technical specifications, ROBAC and End-user declares on the Negotiated Procurement of a Nine (9) Months Lease Contract of an Office Space of PSA NCR I for 2020 CPH Data Processing Center and Census Headquarters as FAILED;

NOW, THEREFORE, for and in consideration of the foregoing, **WE,** the Members of the Regional Office Bids and Awards Committee, hereby **RESOLVED** to declare **FAILED BID** on the Procurement of Lease of an Office Space of PSA NCR I for 2020 CPH Data Processing Center and Census Headquarters with an ABC of One Million Five Hundred Twelve Thousand Pesos (Ph 1,512,000.00) and recommends for the approval of the Head of the Procuring Entity.


