



**ROBAC Resolution No. 17, Series of 2020**

**A RESOLUTION DECLARING CANCELLATION  
OF PHILGEPS REFERENCE NO. 7144846/SOLICITATION NO. PSA-NCR-RO-2020-17,  
MODIFICATION ON THE NUMBER OF PARTICIPANTS AND APPROVED BUDGET FOR THE  
CONTRACT (ABC) IN THE MEAL ACCOMMODATIONS FOR 6-DAYS TRAINING ON THE 2020  
CENSUS OF POPULATION AND HOUSING (CPH)- THIRD LEVEL TRAINING OF PSA-NCR PO V**

**WHEREAS, RA 10625 otherwise known as the Philippine Statistical Act of 2013** mandates the Philippine Statistics Authority (PSA) as primarily be responsible for all national censuses and surveys, sectoral statistics, consolidation of selected administrative recording system and compilation of national accounts;

**WHEREAS,** the Request for Quotation on the Meal Accommodations for 2020 CPH-Third Level Training of PSA-NCR PO V with PhilGEPS Reference No. 7144846 and an Approved Budget for the Contract (ABC) in the amount of Three Hundred Thirty One Thousand Eight Hundred Pesos (Ph331,800) was posted at PhilGEPS and PSA website on July 29, 2020;

**WHEREAS,** on July 30, 2020, ROBAC Secretariat received from the Regional Office, a duly signed Purchase Request (PR) modifying the activity;


**WHEREAS,** the second PR indicated a decrease in the number of attendees, from 158 participants to 61, the ABC from Ph331,800 to Ph128,100 and the date of training from August 4-9, 2020 to August 4-8 and 10, 2020;


**WHEREAS,** ROBAC decided to cancel PhilGEPS Reference No. 7144846 / Solicitation No. PSA-NCR-RO-20-17 and modify the number of participants from 158 participants to 61 and to move the date of the 2020 CPH 3rd Level Training from August 4-9, 2020 to August 4-8 and 10, 2020;

**WHEREAS,** the ABC will be decreased from Three Hundred Thirty One Thousand Eight Hundred Pesos (Ph331,800) to One Hundred Twenty Eight Thousand One Hundred Pesos (PH128,100);


**NOW,** therefore and in consideration of the foregoing, we, the Members of the Regional Office Bids and Awards Committee, hereby **RESOLVED** as it is hereby **resolved**, to amend the Approved Budget Contract on the Meal Accommodations for 6-Days Training on the 2020 CPH- Third Level Training of PSA-NCR PO V to ONE HUNDRED TWENTY EIGHT THOUSAND ONE HUNDRED PESOS (Ph128,100) and recommend for the approval of the Head of the Procuring Entity.

**RESOLVED** this 30<sup>th</sup> day of July 2020 at Quezon City, Philippines.




